## Pallone, Wyden Call on Administration to Stop Allowing Harmful Medicaid Waivers

On February 19, House Energy & Commerce Committee Chairman Frank Pallone (D-NJ) and Senate Finance Committee Ranking Democratic Member Ron Wyden (D-OR), sent a <u>letter</u> to Department of Health and Human Services (HHS) Secretary Alex Azar about waivers that impose restrictions on Medicaid eligibility. The letter asserts that these waivers "undermine access to health care and violate the plain text and purpose of Title XIX of the Social Security Act and Congress's longstanding intent for the Medicaid program." In addition, the letter says that "new evidence indicates that the Administration is failing to appropriately track or evaluate the impact of these misguided policies." In conclusion the authors urge the Secretary "to put a halt to any and all Section 1115 demonstration requests that jeopardize the health and financial security of millions of low-income Americans." ### **Hearing on Restraint and Seclusion**

A hearing titled <u>Classrooms in Crisis: Examining the Inappropriate Use of Seclusion and Restraint</u> has been scheduled for February 27 before the Subcommittee on Early Childhood, Elementary, and Secondary Education of the House Education and Labor Committee. The hearing relates to the expected reintroduction of a bill from the last Congress, the *Keeping All Students Safe Act* (115<sup>th</sup> Congress <u>H.R.7124</u> and <u>S.3626</u>). A live-stream of the hearing will begin at 10:00 am ET on the <u>committee website</u>.

### **Hearing on Drug Pricing**

On February 26, the Senate Finance Committee held a hearing on prescription drug pricing, with witnesses from seven major pharmaceutical manufacturers. ### **Insulin Investigation**

In related news, last Friday, Chairman Grassley and Ranking Member Wyden launched an investigation into the price of insulin. As explained in the <u>committee press release</u>, they sent letters to leading insulin manufacturers Eli Lilly, Novo Nordisk, and Sanofi asking for specific information regarding recent price increases for insulin, including the process used to determine list and negotiated prices; the cost of research and development, production, marketing and advertising; profits; and the companies' funding of patient-assistance programs and third-party tax-exempt organizations. # Palliative Care and Hospice Education and Training Act Introduced

The bipartisan *Palliative Care and Hospice Education and Training Act* (H.R. 647) has been reintroduced in the House by Representatives Eliot Engel (D-NY), Tom Reed (R-NY), Yvette Clark (D-NY), Buddy Carter (R-GA), Frank Pallone (D-NJ), and Greg Walden (R-OR), and now has over 100 cosponsors. The bill would expand and promote palliative care and hospice research, education, and training, and would institute a campaign to raise national awareness for palliative care. In the last Congress, similar bills were introduced in the House and Senate. The Senate bill was introduced by Sen. Tammy Baldwin (D-WI) and garnered 56 cosponsors (a majority of the Senate.) The Hospice Action Network has prepared a <u>summary</u> of the legislation.

# House Passes Bipartisan Poison Control Bill

On February 25, the House passed the bipartisan Poison Center Network Enhancement Act of 2019 (<u>H.R. 501</u>) by voice vote. The bill, which would reauthorize the national network of Poison Control Centers, has not yet been acted upon in the Senate.

# WORTH REPEATING: ACE Kids Act Introduced in the House and Senate

During the last Congress, the Advancing Care for Exceptional Kids Act (ACE Kids Act) was passed by the House as part of a larger bill, but did not make it to the Senate. Since it is a new Congress, all legislation must be reintroduced. On February 4, Senators Chuck Grassley (R-IA) and Michael Bennet (D-CO) introduced the Advancing Care for Exceptional Kids Act of 2019 (S. 317), and have since been joined by cosponsors from both sides of the aisle. A similar bill (H.R. 1226), also bipartisan, was reintroduced in the House by Representatives Kathy Castor (D-FL), Gus Bilirakis (R-FL), and Jaime Herrera Beutler (R-WA), and subsequently cosponsored by Rep. Joe Neguse (D-CO). The ACE Kids Act would amend Medicaid law to let states provide coordinated care for children with complex medical conditions through a health home, and would facilitate the provision of care across state lines. # **MEDICAID WAIVERS**

# Advocates and Healthcare Providers File Brief in Case Challenging the Kentucky Medicaid Waiver

As reported in previous Updates, the administration has been supportive of waivers to establish "community-engagement" (work, education) requirements on Medicaid beneficiaries. See <u>1115</u> <u>Community Engagement Initiative</u> on the Centers for Medicare and Medicaid Services (CMS) website Medicaid.gov. CMS has approved several such waivers in various forms, some of which have been challenged in court. A federal district court invalidated the Kentucky waiver, remanding it to the Department of Health and Human Services (HHS) for reconsideration. After the administration reapproved the waiver in November 2018, the approval was challenged again in court. In January, an <u>amicus (friend-of-the-court) brief</u> was submitted by the American Academy of Pediatrics,

American College of Physicians, the American Medical Association, American Psychiatric Association, Catholic Health Association of the United States, March of Dimes, and National Alliance on Mental Illness. As explained in <u>Health Care Providers, Advocates Explain Harm of Medicaid Work Requirements</u> (blog post from the Center on Budget and Policy Priorities, 2/21/19), the *amicus* brief argues that work requirements can harm Medicaid beneficiaries in several ways.

# WORTH REPEATING: Updated 1915(c) Waiver Application

On January 28, 2019, CMS released a revised application and technical guide for Medicaid 1915(c) waivers, used to provide home-and community based services. According to this <u>information provided</u> by the National Association of States United on Aging and Disabilities, the application includes some notable additions and modifications including:

- A request for information about whether the state administers any quality of life/quality of care surveys of waiver participants, such as the NCI or NCI-AD surveys; and
- Updates to several sections to reflect recent guidance and policy developments, including the sections on public input and self-direction.

# **MEDICAID RESOURCES**

**WORTH REPEATING**: The Kaiser Family Foundation has released a new brief, <u>Section 1115 Medicaid</u> <u>Demonstration Waivers: The Current Landscape of Approved and Pending Waivers</u>. The brief discusses some of the newer elements of Medicaid waivers, including "community-engagement" (work, etc.) requirements, substance-abuse initiatives, and the use of Medicaid to pay for services to address the social determinants of health (a North Carolina pilot program to address housing instability, transportation, food insecurity, and interpersonal violence and toxic stress).

# **Child and Adolescent Health Measurement Initiative: National Survey of Children's Health**

The Data Resource Center (DRC) for Child and Adolescent Health, in collaboration with the Health Resources and Services Administration's (HRSA) Maternal and Child Health Bureau (MCHB), has released the combined 2016-2017 National Survey of Children's Health (NSCH) data sets and codebooks, available at <u>childhealthdata.org</u>. The combined 2016-2017 NSCH is the first multi-year data set since the redesign of the NSCH in 2016, and includes data from over 71,000 children ages 0-17 years. Single year 2017 NSCH data findings, downloadable data sets, and codebooks will be available through the DRC in Spring 2019. The Federal Emergency Management Agency (FEMA) is accepting applications until March 15, 2019, for 12 open positions on its National Advisory Council. They are seeking one person to fill the slot called "*Disabilities, Access and Functional Needs*." This person must be in a position to represent one or more of these groups: *individuals with disabilities*, older adults, and individuals with limited English

## NEW SNAP Work Requirements – Due April 2, 2019.

Earlier this month, the U.S. Department of Agriculture announced a <u>proposed rule</u> that would enforce time limits on SNAP (food stamp) benefits for individuals who do not document sufficient weekly work hours. Comments are due April 2, 2019.

## Pain Management Task Force Draft Report – Due April 1, 2019

The Comprehensive Addiction and Recovery Act of 2016 (CARA), requires that the public be given at least ninety (90) days to submit comments on any proposed updates and recommendations developed by the <u>Pain Management Best Practices Inter-Agency Task Force</u> (Task Force). The Task Force is requesting comments on its <u>Pain Management Best Practices</u>: <u>Updates, Gaps, Inconsistencies, and Recommendations (PDF)</u>, which includes sections on <u>Unique Issues Related to Pediatric Pain</u> <u>Management; Sickle Cell Disease</u>; and <u>Health Disparities in Racial and Ethnic Populations, Including African-Americans, Latinos, American Indians, and Alaska Natives</u>. <u>Submit comments.</u>

# **Electronic Health Information – due early April**

On Monday, February 11, 2019, the Centers for Medicare & Medicaid Services (CMS) released a <u>proposed rule</u> intended to facilitate the use of electronic health information and promote patient access to and control over their health information.
