# **House and Senate Bills to Extend F2F Funding - UPDATE**

As reported in the May 29 Update, Representatives Mikie (Michelle) Sherrill (D-NJ) and Fred Upton (R-MI) introduced the Family-to-Family Reauthorization Act of 2019 (H.R. 2822) on May 17. Senators Chuck Grassley (R-IA) and Robert Menendez (D-NJ) introduced a companion Senate bill. The bipartisan bills would extend funding for the grant program that funds Family-to-Family Health Information Centers (F2Fs) for an additional five years, through federal FY 2024, at the current level of \$6 million per year. On June 4, the Health Subcommittee of the House Energy & Commerce Committee held a hearing on H.R. 2822 and 11 other bills to extend existing health programs. Since then, another cosponsor has joined – Rep. Debbie Dingell (D-MI). More details on these House and Senate F2F extension bills can be found on the Family Voices website.

Meanwhile, Rep. Michael Burgess (R-TX), the Ranking Republican Member of the Health Subcommittee, introduced legislation (<u>H.R. 2700</u>) to extend the Family-to-Family program, and the other programs that were subjects of the June 4 hearing, for *one* more year (through FY 2020). That bill is cosponsored by all of the Republican subcommittee members, even though some of them have also sponsored bills to extend some of the programs for longer than one year. Rep. Burgess favors extending these programs, but is concerned about doing so without an "offset" to cover the federal cost of the extensions. His bill would provide an offset by establishing measures to lower the cost of prescription drugs, thus reducing costs for federal healthcare programs. See Rep. Burgess' <u>hearing</u> statement.

#### **Disaster Relief Bill Enacted – Includes Funds for Territories**

As reported in the May 29 Update, the Senate passed a broad, \$19 billion disaster relief package to provide assistance to the areas of the US affected by fires, floods, and other natural disasters, including Puerto Rico and other territories. The House later passed the bill and the president signed it on June 6 (Public Law No: 116-20). The bill would provide nutrition assistance funding for both Puerto Rico and American Samoa and other assistance for Puerto Rico (see a press release from the office of Senator Menendez). # **Credit for Caring Act Introduced**

On May 14, the bipartisan *Credit for Caring Act* was introduced in both the Senate and House. The Senate bill (S. 1443) was introduced by Senators Joni Ernst (R-IA), Michael Bennet (D-CO), and others. The House bill (H.R. 2730) was introduced by Representatives Linda Sánchez (D-CA) and Tom Reed (R-NY). The bill would provide tax credits to eligible caregivers for some of the cost of in-home care, adult day care, respite care, and other services. An "eligible caregiver" is defined as an individual who has earned income for the taxable year in excess of \$7,500 and pays or incurs expenses for providing care to a spouse or other dependent relative with long-term care needs. The tax credit would be equal to 30 percent of qualified expenses above \$2,000, and would be a maximum of \$3,000 per year.

#### **MEDICAID WAIVERS**

**From CMS:** South Carolina submitted an application requesting a new five-year section 1115 demonstration to implement a community engagement requirement, expansion of benefits, and a targeted substance use disorder program. All non-disabled individuals under the age of 65 covered by Medicaid, including parents and caretakers, children, pregnant women, and those needing substance use disorder treatment would be impacted by this demonstration. The federal comment period will be open from June 10, 2019 through **July 10, 2019**.

# Open Season Announcement for Certified Designated Organizations - Live Application Link will be available June 12.

The Centers for Medicare & Medicaid Services (CMS) is inviting organizations that would like to become Certified Application Counselor Designated Organizations (CDOs) to apply during CMS's Open Season beginning June 12, 2019, and ending September 16, 2019. In the Federally-facilitated Marketplace, CDOs oversee certified application counselors (CACs) who are trained and able to help consumers seeking health coverage options through the Marketplace. Any organization seeking to provide CAC enrollment assistance to consumers for Plan Year 2020 must be a certified CDO. In order to be designated as a CDO, you must submit an online application and enter into an agreement with CMS. If your organization completed the CDO refresh process last year and received a new CDO identification number and a welcome packet, then you do not need to reapply. # Due June 21, 11:59 pm ET. Federal Inflation Measures for Poverty Thresholds

On May 7, the Office of Management and Budget (OMB) – part of the White House – issued a "Notice of Solicitation of Comments" about what consumer price index should be used to establish the "Official Poverty Measure," which serves as the basis for poverty guidelines used to determine income-based eligibility for programs such as Medicaid and CHIP. Should OMB ultimately adopt a different inflation index, it could reduce the number of people eligible for these programs, and these reductions would become greater over time.
