Congress is still in recess, and will return on October 15. Outstanding issues to tackle when they get back include appropriations to keep the government funded past November 21, and legislation to address surprise medical bills and prescription drug costs. It is not clear whether a consensus can be reached on those contentious issues. On the judicial front, the US Circuit Court of Appeals for the 5<sup>th</sup> Circuit is expected to issue its decision soon in *Texas v. United States*, about whether the Affordable Care Act is constitutional. In other news, the Title V NOM/NPM data from the Combined 2017-2018 National Survey of Children's Health are now available at <a href="www.childhealthdata.org">www.childhealthdata.org</a>! #### THE COURTS

At any moment, the US Court of Appeals for the 5<sup>th</sup> Circuit could announce its decision in <u>Texas v. the United States</u>, the case challenging the constitutionality of the Affordable Care Act (ACA). The district court had ruled in December 2018 that the entire ACA is unconstitutional. A three-judge panel of the appeals court heard arguments in July. Although the administration has argued that the law is unconstitutional, it reportedly will seek a "stay" (postponement) of the decision, pending appeal, should the court invalidate the law. Either party to the case law could ask for the court of appeals to re-hear the case "en banc" – before *all* the judges of the court – or could appeal the case directly to the Supreme Court.

<u>Background</u>. As reported in <u>earlier Updates</u>, the state of Texas and 17 other states challenged the constitutionality of the Affordable Care Act (ACA) in <u>Texas v. United States</u>. The district court ruled that the entire law is unconstitutional because Congress lowered to zero the tax penalty for failing to have insurance, thus undermining the constitutional basis of the law – Congress' taxing power. The Department of Justice, which normally defends existing laws, decided to side with the plaintiffs *against* the law; the lower court allowed other states and the House of Representatives to join the case in defense of the ACA. It would be very difficult to find an alternative to the ACA that could get through the current Congress. #### **CONGRESS**

Congress is in recess until October 15. When they return, they *must* address FY 2020 appropriations, because the "continuing resolution" enacted last month expires on November 21. See <a href="Short-Term">Short-Term</a> Funding Bill Keeps Government Open, Also Includes Sound Provision Reducing Federal and State <a href="Medicaid Drug Costs">Medicaid Drug Costs</a> (Georgetown Center for Children and Families blog post, 10/3/19). There is still continued interest in addressing prescription drug prices and surprise medical billing. Those are both controversial issues, however, so it may be difficult to craft legislation that can get through Congress. More information about these issues can be found in the October 3 Update.

With respect to **surprise medical bills**, the chairman of the House Ways and Means Committee, Richard Neal (D-MA), has <u>suggested</u> that Congress enact a law requiring the administration to undertake a "negotiated rulemaking process." Under such a plan, the administration would convene a committee consisting of key stakeholders (doctors, hospitals, insurers) and the Departments of Health and Human Services, Treasury, and Labor. That committee would recommend parameters for setting payment rates for surprise bills, while ensuring that consumers would be held harmless. The federal departments would then develop a proposed rule with a public comment period. The key stakeholders have different positions on how to pay these out-of-network payments. Physicians, physician practice groups, and hospitals prefer negotiated rates, while insurers prefer a "benchmark" approach. # **WORTH REPEATING:** CMS is Bringing Health Plan Quality Ratings to All Exchanges for the First Time

For the first time, the Centers for Medicare & Medicaid Services (CMS) will require the display of the five-star Quality Rating System (or star ratings) available nationwide for health plans offered on the Health Insurance Marketplaces beginning with the 2020 Open Enrollment Period. Beginning with this year's Open Enrollment Period, consumers will be able to compare health coverage choices using a five-star quality rating of each plan on Marketplace websites, including <a href="HealthCare.gov">HealthCare.gov</a>, similar to other CMS star rating programs, such as the Nursing Home Compare website. # Applicants for Immigrant Visas Must Demonstrate Plan for Getting Insurance Coverage or Ability to Pay Medical Expenses

On October 4, President Trump signed a proclamation -- Presidential Proclamation on the Suspension of Entry of Immigrants Who Will Financially Burden the United States Healthcare System. The proclamation announces that the government will accept immigrant visa petitions made abroad only if the applicant can demonstrate that he/she will be able to secure health insurance within 30 days of arriving in the US, or has the financial resources to pay "reasonably foreseeable medical costs." The requirement does not apply to tourists or certain other individuals, including: children of US citizens; other children under the age of 18 unless, they are accompanying a parent who is also immigrating to the United States and is subject to the requirement; asylees; or refugees. The proclamation also lists the types of insurance coverage that meet the requirement. Among others, short-term plans will be acceptable, as will Medicaid coverage for children through age 18. # <u>Trump Administration Empowers Nursing Home Patients, Residents, Families, and Caregivers by Enhancing Transparency about Abuse and Neglect</u>

Later this month, the Centers for Medicare & Medicaid Services (CMS) will be adding a new feature to the <u>Nursing Home Compare website</u>. It will display a consumer alert icon next to nursing homes that have been cited for incidents of abuse, neglect, or exploitation. This website already provides information about whether a facility meets federal standards with respect to health and safety compliance inspections, staffing levels, and quality measure performance. The new format and icon will make it easier to quickly identify nursing homes with past citations for abuse.

The Data Resource Center for Child and Adolescent Health (DRC), under a cooperative agreement with the Health Resources and Services Administration's (HRSA) Maternal and Child Health Bureau (MCHB), is excited to announce the release of the National Performance Measures (NPMs) and National Outcome Measures (NOMs) data findings from the Combined 2017-2018 National Survey of Children's Health (NSCH). All data are available through the interactive data query on <a href="mailto:childhealthdata.org">childhealthdata.org</a>! The combined 2017-2018 NSCH is the second multi-year data set since the <a href="mailto:redesign of the NSCH">redesign of the NSCH in 2016</a> and includes data from 52,129 children ages 0-17 years.

#### Special Enrollment Period Available for Victims of 2019 Hurricane Dorian

Consumers who qualified for an another enrollment period, such as a special enrollment period (SEP) or Open Enrollment Period (OEP), but were unable to complete a Marketplace application, plan selection, or enrollment process due to Hurricane Dorian, may have access to an Exceptional Circumstances Special Enrollment Period (SEP). These individuals have 60 days from the end of the FEMA-designated incident period to complete their 2019 enrollment and request a retroactive start date based on when he or she would have picked a plan if not for Hurricane Dorian. Consumers will be considered "impacted" and eligible for this SEP if they reside, or resided at the time of the hurricane, in any of the counties declared as meeting the level of "individual assistance" or "public assistance" by the Federal Emergency Management Agency (FEMA). See 2018 guidance on Special Enrollment Period (SEP) policy for consumers impacted by an emergency or major disaster. Assisters, agents, and brokers can help affected consumers by contacting the Marketplace Call Center at 1-800-318-2596 or TTY at 1-855-889-4325 to request enrollment using this SEP.
