There are two big news items in the health policy world this week:

- The Supreme Court lifted an injunction that had been stopping implementation of the administration's "public charge" rule, but only while appeals are pending.
- The Centers for Medicare and Medicaid Services (CMS) will be unveiling guidance to states on how they can "block grant" or receive per capita caps for coverage of certain adults.

# THE COURTS

## Supreme Court Allows Administration to Enforce "Public Charge" Rule, Pending Appeal

On January 27, the <u>Supreme Court lifted a nationwide-ban</u> (injunction) on enforcement of the "public charge" rule, *pending further appeals.* This means that the administration can start enforcing the rule (except in Illinois, where there is a statewide injunction), although it still may be struck down eventually. The "public charge" rule would make it easier for the government to deny green cards or entry visas to people deemed to be at risk of becoming a "public charge," i.e., dependent on public benefits. It is important to remember that the rule does NOT affect children's eligibility for Medicaid or other programs, and that a child's use of such programs will NOT be held against his/her family members. The injunction against enforcing the rule could be re-instituted in the future. A case on that issue will be heard as early as next month in U.S. Court of Appeals for the Second Circuit (based in NY). That case could be further appealed to the Supreme Court. Ultimately, the courts will rule on the validity of the rule itself.

## THE ADMINISTRATION

#### CMS Guidance Allowing States to Partially "Block Grant" their Medicaid Programs

On Thursday, January 30, the administration plans to unveil new guidance on how states can partially restructure their Medicaid programs by receiving fixed amounts to cover adults in the "expansion population" (childless adults that states have the option to cover under Medicaid pursuant to the Affordable Care Act). Currently, states receive federal payments based on what they actually spend. A one-hour, live-stream <u>presentation</u> about the guidance - *Transforming Medicaid: A New Opportunity for Better Health* - will begin Thursday, January 30, at 10:30 AM EST. ## CONGRESS

#### Hearing on Paid Family Leave

On January 28, the House Ways & Means Committee held a <u>hearing</u> on paid family leave. Committee member Rep. ## <u>WORTH REPEATING</u>: Request for Information on Out-of-State Provision of Medicaid Services for Children with Medically Complex Conditions

On January 21, the Centers for Medicare and Medicaid Services (CMS) published a <u>Request for</u> <u>Information</u> on "Coordinating Care from Out-of-State Providers for Children with Medically-Complex Conditions." CMS is seeking public comments on:

- Best practices for using out-of-state providers in coordinating care for children with medically complex conditions;
- How care is coordinated for such children when that care is provided by out-of-state providers including when care is provided in emergency and non-emergency situations; and
- Processes for screening and enrolling out-of-state providers, including efforts to streamline these processes or reduce the burden of these processes on such providers and states.

Comments are due on March 23.

#### **Pending State Waiver Requests**

**Georgia.** Georgia has submitted a new, five-year <u>Sec. 1115 demonstration proposal</u> to CMS that would create a **new eligibility group restricted to individuals with incomes between 35 percent and 100 percent FPL who work at least 80 hours a month**. Those with incomes above 50 percent FPL would also have to pay a monthly premium to maintain eligibility. The <u>federal comment period</u> is open until **February 7, 2020.** 

Idaho. On January 3, 2020, Idaho requested a new 5-year <u>section 1115 demonstration</u> that would allow the state to receive federal financial participation for inpatient, residential, and other services provided to otherwise-eligible Medicaid beneficiaries while residing in **institutions for mental diseases** (IMD) for diagnoses of substance use disorder (SUD) and/or serious mental illness (SMI)/serious emotional disturbance (SED). Federal public <u>comments can be submitted</u> through February 8, 2020.

Illinois. Illinois has submitted an application for a <u>new 5-year section 1115 demonstration</u> seeking authority for three initiatives: (1) Extension of the postpartum coverage from 60-days to 12-months;
(2) Managed care organization (MCO) reinstatement for Medicaid beneficiaries who submit late

redetermination paperwork within 90-days; and (3) **The waiving of hospital presumptive eligibility (HPE)**. <u>Comments can be submitted</u> through **February 13, 2020.**

## **Proving Disability More Frequently – Due January 31**

As reported in earlier Updates, the Social Security Administration has issued a proposed rule -<u>Proposed Rule Regarding the Frequency and Notice of Continuing Disability Reviews</u> under which "continuing disability reviews" (CDRs) would be conducted more frequently for people with certain conditions, including children with certain behavioral conditions, cancers, asthma, and some other conditions. Additional reviews may also be required when children are nearing ages 6 and 12. Comments can be submitted easily via <u>this page on Regulations.gov</u>.

## Input Sought from Family Caregivers – due February 7

The Administration for Community Living (ACL) is seeking input, from individuals and organizations, on the challenges faced by family caregivers and ideas about how to address them. This information will be used to assist the <u>RAISE Family Caregiving Advisory Council</u> in developing a national family caregiving strategy and planning future activities, including public listening sessions that will begin this year. #### NEW: Request for Input about Grandparents Raising Grandchildren – due Feb. 7

The Administration for Community Living (ACL) is requesting information to assist the <u>Advisory Council</u> to <u>Support Grandparents Raising Grandchildren</u> in developing an initial report to Congress, which will include best practices, resources, and other useful information for grandparents and other older relatives raising children. See the <u>Federal Register notice</u>. ACL seeks public input on information, resources, programs, and/or best practices to help grandparents, other relatives, and kinship caregivers. It is also requesting information about gaps and/or unique needs related to specific caregiver populations, such as Native Americans. **Comments are due by 11:59 p.m. EST on February 7, 2020.** More information and a form to submit comments can be found on <u>this webpage</u>.

## **Organ Donation Regulations – due February 21, 2020**

On December 17, the administration announced a proposed rule intended to increase the number of organ donations. ## DOT Seeks Input on Proposal to Make Airplane Lavatories More Accessible – due March 2

The U.S. Department of Transportation (DOT) seeks public comments on a new <u>proposed rule</u> to improve restroom access for passengers with disabilities on single-aisle aircraft with 125 or more seats. The rule is based on <u>negotiated rulemaking</u> undertaken by DOT's Advisory Committee on Accessible Air Transportation, which included aviation industry representatives, disability rights advocates, and other stakeholders. The proposed regulation addresses lavatory interiors, on-board wheelchairs, and training of flight attendants. **Comments are due by March 2, 2020, and can be submitted** <u>here</u>.
