
#### December 2022

End of Medicaid Continuous Enrollment effective March 31, 2023 States given 12 months to return to normal eligibility and enrollment




#### **Total Monthly Medicaid and CHIP Enrollment**

people have been disenrolled from Medicaid.



## **Eligibility for Medicaid**

#### **Children's Health Insurance Program**

CHIP provides low-cost health coverage to children in families that earn too much money to qualify for Medicaid. In some states, CHIP also covers pregnant women. Each state offers CHIP coverage, which is administered by states, according to federal requirements. The program is funded jointly by states and the federal government.





## The Challenges



#### **Redetermination and Renewal**



- Historically, about 17 million people lose their Medicaid or CHIP coverage each year at the point of renewal or redetermination.
- Each state has a different approach to their normal renewal process, and it has been left up to the states how to handle the process of redetermination at the end of the Public Health Emergency.



#### Redetermination and Renewal



Based on historical numbers, it is estimated that more than

50 Million people will lose Medicaid coverage this year, as the Public Health Emergency ends.



## The Challenges

- Three years' worth of renewals in one year
- Outdated systems
- Families have moved without notifying of the change in address
- Staffing







## How's it Going?



- 71% of terminations in July were for procedural reasons (<June)
- 25% of cases due for renewal by the end of July were still pending at the end of the month. (>June)
- Average ex-parte renewal rate was 31% (>June)



## How's it Going?



- In August 2023, The Biden Administration made states aware that many of the ex-parte redeterminations were based on an incorrect use of software that automatically verified eligibility
- Mail delays, incorrect addresses and unclear documents have contributed significantly to procedural terminations



## **Unwinding Waivers**



As of 9/20/203 CMS had approved 319 waivers for 49 states and the District of Columbia

- Increase ex parte renewals (47 states)
- Help enrollees complete and submit forms (44 states)
- Updating contact information (43 states)
- Help with re-enrollment after procedural disenrollment (31 states)
- Retroactive re-enrollment

## Impact on Families



- Entire families lose may coverage.
- Some members of a family may lose coverage while others do not.
- Variations between states can cause confusion.
- Availability of programs for CYSHCN can be drastically different.
- Lost coverage can mean an impact to services.
- Lost coverage can come as a surprise.



## **Kaiser Family Foundation**



The Medicaid Enrollment and Unwinding Tracker presents the most recent data on monthly Medicaid disenrollments, renewals, overall enrollment and other key indicators reported by states during the unwinding of the Medicaid continuous enrollment provision. The unwinding data are pulled from state websites, where available, and from the Centers for Medicare & Medicaid Services (CMS)







## **Supporting Families**



#### What can families do?



- Keep contact information up to date with the Medicaid or CHIP agency.
- Watch the mail for communications about Medicaid coverage.
- Return requested paperwork as soon as possible.
- Save a copy of everything sent.
- Make sure to get receipts or proof of submission.



#### What can F2Fs and AOs do?



- Share information about Medicaid Redetermination.
- Share information about alternatives to Medicaid.
  - Include waiver programs, where available.
- Work with community partners or schools to spread information even more widely.
- Offer navigation support to families.
- Ensure that information is provided in multiple languages.
- Partner with your Medicaid or CHIP agencies.
